Funds for the following activities are approved under Scheme 6 XV FC Health Sector grants.

- 1. Urban Multi-Disciplinary Unit for the Total Health Care of Elderly Rs. 1433.39 lakhs
- 2. 360 degree NCD care centre Rs. 1260 lakhs.

In the following institutions where funds are sanctioned for the activities, there is difference among the actual governing body of HMC and the fund transferred local governments. In such institutions, it has been advised that Health department has to designate a medical officer as the implementing officer of the project as per clause 3.1 of reference mentioned. Since Superintendents of these institutions are already officers implementing palliative care projects of these ULBs, it is recommended that the Superintendents be designated as implementing officers for Urban Multi-Disciplinary Unit for total healthcare of elderly and for 360 degree NCD care centres.

## **Establishing 360 degree Metabolic Centers in Districts**

Non communicable diseases are on the rise in the State of Kerala which is placed in the highest epidemiological transition zone with statistics pointing that one among 3 being hypertensive and 1 in 5 being diabetic. Along with this rising epidemic, the complications of these diseases like, heart disease, renal diseases, Cancer, ulcers etc are also increasing in the State altering the mortality tables adversely. The solution to this situation is the early screening for complications in patients with NCDs. A Novel idea of 360 degree Metabolic Centre as PPP model was piloted in G H Ernakulum in 2018 for screening of NCDs and its complications under one roof. The model may be replicated in all districts in 2 selected hospitals.

**Concept:** The concept of 360 degree Metabolic is the provision of testing for NCDs and its complications in one go. The room will be divided in to Cabins for checking basis tests like HT, DM, BMI in one cubicle, Diabetic foot examination in another cubicle, Retinopathy Clinic, PFT clinic, Nephropathy testing, cancer clinic, Diet counseling, smoking cessation and Medical consultation in individual cubicles. The new patient has to visit all these cabins for having a 360 degree metabolic care and thereby all diseases could be detected much early even before the symptoms.

The treatment may be initiated by the NCD doctor or may refer to the physician. The follow up of the patient shall be ensured by the centre staff through prompt registration. Medicine will be issued through the Hospital pharmacy.

**Infrastructure:** Size may be adjusted as per the space availability. Cabins may be set up using prefabricated cubicles (Calcium Silicate board partition work) interior paintings, False ceiling work with Gypsum board. Glass partition window. The districts may choose their own mode of construction and agency. A toilet may be constructed adjacent to the centre if required for collection of urine sample. A patient waiting area with airport chairs, drinking water facility and adequate IEC including video projection shall be ensured

**Color:** The Paint shall be white with sky blue lining. The logo of DHS, NHM and **Amruthum Arogyam** shall be exhibited. A board showing 360 degree metabolic Centre shall be exhibited.

**Staff:** One staff Nurse will be provided by NHM. Doctors, Dietician, Staff Nurse of existing NCD clinics in facilities available shall be deployed in the 360 clinics. Other hospitals can utilize the existing staff from their system

The responsibility of regular functioning of the centre will be with the physician assigned by the superintendent of the Hospital irrespective of the availability of NHM doctor.

**Waste Disposal-** The necessary biomedical waste management system shall be ensured and all materials related to waste collection as per the standards shall be procured

**Data:** Data from the 360 degree will be stored in the e health server.

**Reporting:** The report of the 360 degree centre will be submitted to the District NCD Cell Monthly. The data evaluation will be done quarterly

**Funds:** 15<sup>th</sup> Finance commission funds of up to Rs. 45 lakh for 1 Centre. If there is any delay in getting funds from 15<sup>th</sup> finance Commission funds may be utilized from NHM funds which may be recouped on availability of 15<sup>th</sup> Finance Commission funds.

# <u>Comprehensive Elderly Care Unit – SOP</u>

Under the Fifteenth Finance Commission grants it is proposed to setup 1 Comprehensive Geriatric Care Unit in all districts. The Standard Operating Procedure for establishing the units is attached below:

## **Standard Operating Procedure:**

Concept – A Comprehensive Geriatric Care Unit for managing the elderly Care issues, which include preventive, curative and Rehabilitative aspects of elderly Care under one umbrella, is proposed. The facilities include Geriatric OP, 10 Bedded well furnished Geriatric IP, Physiotherapy unit and Rehabilitation Centre.

**OP:** OP will be functional 6 days a week from 9 am to 4 pm. The service of 1 doctor will be exclusively dedicated for the service. 1 Staff Nurse will assist the doctor in the OP department, who will also manage the routine OP procedures. Specialty OP will be conducted on selected days on rotation. Specialty includes General Medicine, Orthopedics, Skin, ENT, Cardiology, Psychiatry, Neurology etc, depending on the availability of the Specialists. If the in-house specialists are not available, doctors may be hired from outside based on the availability.

**IP:** 10 bedded IP facility will be set up in the hospital with Geriatric friendly settings like Anti Skid Tiles, elderly friendly furniture, woody stable cot, Ramps, railings and elderly friendly toilets. The beds should have Oxygen facility and other life saving measures attached.

#### Infrastructure

No new construction is permitted. The space for the Geriatric unit shall be met from the existing space available in the hospitals. The partition, modification, paneling and cubicles shall be done using conventional building materials. Tile work, false ceiling, plumbing works, electrification work shall be done based on the requirement.

**Physiotherapy Unit:** A well established Physiotherapy Unit shall be attached with each Geriatric Unit, List of equipment to be procured is listed below:

**Rehabilitation Unit:** The rehabilitation unit will be attached to be Physiotherapy unit for assisting the elderly population in rehabilitation Service.

**HR:** 1 medical Officer and 1 Staff Nurse will be provided by NHM. The rest of the staff may be utilized from the current pool of existing staff.

Funds: Up to 100 lakhs may be utilized from the Fifteenth Finance Commission Grants.
